Photocopies of the following *must* accompany the application:

- < Driver's license
- < Registration for each truck and trailer
- < Pesticide license, if applicable
- < Certificate of insurance naming the Incorporated Village of Amityville as additional insured (with general liability insurance in the amount of a minimum of **\$1,000,000** for each occurrence, **\$2,000,000** in the aggregate).
Insurance Cards for all vehicles noted on application.
Workers' Compensation Insurance.
- < A check made payable to the Village of Amityville in the appropriate amount
- < Application must be notarized (this can be done at Village Hall when you bring your application in person; must have valid photo ID)
- < Suffolk County Home Improvement License *including* a Suffolk County Nitrogen Fertilizer Turf Management Course Certificate of Completion - **Starting January 1, 2020**. The Suffolk County Nitrogen Fertilizer Turf Management Course Certificate of Completion is **REQUIRED** even if you do **not** use pesticides.

Upon receipt of same, your application will be processed for renewal and upon approval a new license will be issued. **All applications are subject to Board of Trustees approval.**

VILLAGE OF AMITYVILLE YARD WASTE AND GRASS CLIPPING COLLECTION RULES

The Village of Amityville (Village) requests your cooperation in complying with yard waste and grass clipping collection rules. The Town of Babylon collects the refuse and yard waste for the Village and it is collected in accordance with yard waste zones, **BEFORE 8AM** on the days indicated below.

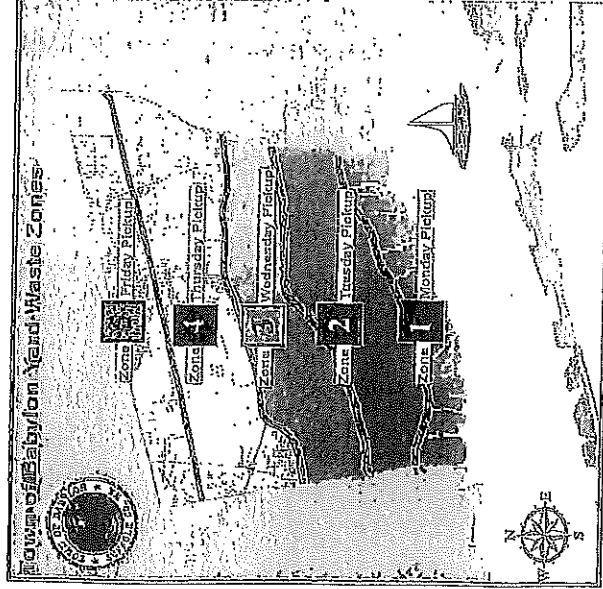
If your customer's yard waste pick up is **NOT** scheduled for the day following when the property is serviced, you **MAY NOT** leave yard waste and grass clippings at curbside. You **MUST** remove the yard waste and grass clippings **OR** leave it on your customer's property in a place designated by them (that is **NOT** at the curbside).

Failure to comply may result in a summons to the homeowner. Village of Amityville Code §97-8 B.

YARD WASTE ZONES



When is your yard waste collected?

In order to increase efficiency and improve safety yard waste is collected according to Yard Waste Zones (YWZ). Please keep yard waste separated from regular garbage. Yard Waste Zones are broken down by region. If your home is located . . .

- YWZ 1** - South of Montauk Highway - Monday pickup
- YWZ 2** - Between Montauk Highway and Sunrise Highway - Tuesday pickup
- YWZ 3** - Between Sunrise Highway and Southern State Parkway - Wednesday pickup
- YWZ 4** - Between Southern State Parkway and Long Island Avenue - Thursday pickup
- YWZ 5** - North of Long Island Avenue or North of LIRR Tracks - Friday pickup
